

Palmyra S.S. Union 1831-1836

Palmyra June 1831

At a meeting of the friends of Sunday Schools to take into consideration and adopt measures for the promotion of the interests of this Institution, the Rev. Mr. Townsend was called to the chair, and Rich. L. Clark was appointed secretary. Celebration was commenced by the Moderators asking the aid of the Holy Spirit, after which the following resolution was submitted and adopted –

Resolved – That this meeting form itself into a Union Society for the promotion of Sunday Schools in this town –

On motion of Mr. Cogswell [illegible]

Resolved – That a committee of three be chosen to rep[illegible] a constitution – Resolved – That Mrs. Theron R. Strong, James F. Cogswell and Pelatiah West compose said committee –

The committee retired and after a short absence reported the following constitution which was adopted. -

Constitution

- **Art. 1**st This Society shall be called the Palmyra Sunday School Union.
- Art. 2d The great object of this Society shall be the promotion of the interest of Sunday Schools and to call into active and united exertion all the friends of the cause in this town.
- Art. 3d Officers of the Society shall be a President, Vice President, a Treasurer, a Corresponding Secretary, a recording Secretary, and four Directors who shall annually be chosen by the society, and who shall constitute a Board of Directors three of whom shall be a quorum? any meeting regularly convened.
- Art. 4th The officers & Directors shall appoint a visiting committee who with the Board shall constitute an executive committee five of whom shall form a quorum any meeting [illegible]
 Shall have power to appoint its own meetings, form its own rules of business, fill any vacancies in its own numbers during their term of service, and to call any meetings of the society; they shall have the disposal of the funds, transact such other business as the interests of the institution may require and shall make a report of their proceedings at the regular meetings of the Society.

- Art. 5th Any person may become a member of this Society by contributing annually to its funds and all officers and teachers of the village school, with officers of auxiliary association shall be ex-officio members.
- Art. 6th Any association may become auxiliary by agreeing to contribute annually to the funds of the Society, and shall be entitled to receive the amount which they pay in books from the Library
- Art. 7th This Society shall meet annually in the village of Palmyra on the "second Wednesday in January –"
- Art. 8th No alteration shall be made in this constitution without a vote of two thirds of the members present at the annual meeting, unless recommended by the board of officers.

For signatures see the subscription Book.

The Society proceeded to the choice of officers, whereupon Deacon Henry Jesup was elected President, Col. George Beckwith Vice-President, Joseph S. Fenton Esqr. Treasurer, Rev. Linus North corresponding Secty, Rich. L. Clark Recording Secty and Mrs. Pelatiah West, Newton Foster, Robert W. Smith, and James F. Cogswell Directors for the ensuing year.

The following resolutions were submitted with appropriate remarks.

Moved by Mr. P. West and seconded by Rich. L. Clark,

That we will make use of every means in our power to establish a Sunday School in every school district in this town, and with the blessing of God to continue them through the year.

Moved by Mr. Theron R. Strong & Seconded by Mr. Newton Foster.

That the preservation of the liberties of our country depends under Heaven on the general prevalence of knowledge and virtue—that Sunday Schools are an efficient means of enlightening the minds of our youth and rendering them virtuous-and that therefore, every patriot is called upon for decicive[sic] exertion in favour of Sunday Schools.

The above resolutions were unanimously adopted.

Voted: That Matthew McCagg, Charles Durfee, Lewis Foster, Joseph B. Fenton, David G. Ely, & Mrs Wealthy Willcox, Miss Ruth Marvin, Catharine Morehouse, Caroline Ely, & Cyntha A. Willcox [illegible, perhaps "help"].

Voted: That the meeting adjourn to Wednesday June 22d at 6 oclock P.M. Closed with prayer by President.

- **Art. 1**st All meetings of the Board shall be opened and closed with prayer.
- Art. 2nd The Directors shall annually appoint the Superentendants,[sic] Librarian, Secretary, & other officers of the village school.
- Art 3rd The Directors shall annually appoint the board of visitants on the first meeting after the yearly election, to consist of as many members as the Board thinks necessary and shall assign to them their respective districts.
- Art. 4 It shall be the duty of visitants to form as soon as possible S.S. associations in the districts assigned to them, assist in forming S. Schools providing teachers and procuring funds to establish a library and to visit their respective schools once a month or oftener.
- Art. 5th The Directors shall appoint as many collectors as necessary to obtain funds and members of the society.
- Art. 6 It shall be the duty of the Superintendants[sic] to preside in schools to see that it be opened with prayer and closed with singing or prayers, to provide teachers and assign to them their classes, to examine at suitable times, the school in their studies, and discharge all other duties which they may feel necessary for the improvement of the school.
- Art. 7th The Librarian shall have the care of the Library attend to the distribution of the books and keep a regular account of them agreeable to the Library Regulations.
- Art. 8 The Secretary shall keep a regular catalogue of the teachers and students of the school, regularly noting the attendance of the same & keeping an account of the number who daily attend.

A code of laws was presented and by resolution recommended to the notice of the visiting committee to introduce into auxiliary schools.

Constitution

Art. 1st This Society shall be called the Palmyra Sabbath School Union and shall be a Branch of the Wayne County Sabbath School Union Art. 2nd The object of this Society shall be to establish and sustain Sabbath Schools in this Town and aid the County Union as far as it has ability. -Art 3rd This Union shall contribute one dollar or more annually to the funds of the County Union and act in concert with its Board of Officers. Art. 4 Every person who contributes to the funds of this Society and all Sabbath School Teachers shall be members. Art. 5th This Society shall annually elect a president Secretary & Treasurer who together with the Superintendents of the Sabbath Schools in the town shall constitute an Executive Board to manage the business Of the Society – three of whom shall constitute a quorum, and in case of a failure of an Annual election they shall hold their officers until a new election is made. Art. 6 The President shall have power to call special meetings – The Executive Board shall have power to regulate its own proceedings in such manner as may appear to them best calculated to promote the interests of the Sabbath School cause. -Art. 7th The Secretary shall notify all meetings of the Society and of the Executive Board, manage the business to be brought before them and keep the minutes of this doings. He shall manage the correspondence of the Society and prepare a report for the annual meeting, a copy of which, together with the list of officers, he shall forward soon after to the Secretary of the County Union -Art. 8 The Treasurer shall Superintend the collection of funds, and together with the Secretary take such measures as the Board shall direct to establish Libraries in all the Schools under their care and make a report at the annual meeting of the Society -Art. 9th There shall be an annual meeting of the Society – on _____ which meeting the Reports of the Secretary & Treasurer shall be read – Officers chosen and one or more delegates appointed to attend the meeting of the Board of Managers and the annual meeting of the County Sabbath School Union

Art. 10th This Constitution may be altered at an annual meeting by a vote of tow thirds of the members present –

Palmyra Village Apr. 1835. The Board of Officers met at the house of Josiah Francis by order of the President.

Meeting opened with prayer by J. F. Cogswell after a free conversation on the fate of the several districts in the Town. The Board? to establish a school in the Brick School House near Mr. Goldsmiths.

- 2nd To establish a school in the Brick School House near Wm. Rogers.
- 3d To establish a School in the North East part of the Town under the superintendence of Dennis Clark.
- 4th To establish a school in the School House near to Noah Balones?.
- 5th To endeavour[sic] to establish Schools bordering on the south line of this town.

Adjourned.

Linus North Sect.

June 1835 Board of Officers met at the House of the President Josiah Francis.

Resolved That the Town? Union will hold a Sabbath School celebration on the fourth of July.

Resolved That Misses? Cely?, Jessup, Horton & others be a committee to make the necessary arrangements.

July 4th 1835 The Schools of the Town met and celebrated the day. Exercises in the Presbyterian meeting House. Refreshments at the Methodist Chapel.

The exercises of worship were conducted by the Clergy of the Town.

The Declaration of Independence was read by Mr. Joseph Hyde Esq. Accompanied with expository remarks.

An? was delivered by Mr. Howe of Canandaigua.

Linus North Sect.

Palmyra May 4th 1836 Palmyra Sabbath School Union held its annual Meeting in the Stone School House in East Palmyra.

The President being absent Elec. Hiram Foster was called to the chair.

Meeting opened by prayer by L. North.

Report of the Board of Officers was read by the Secretary. From which it appears that there were nine Sabbath Schools in the town the past year.

There were Ninety four Teachers, five hundred and seventy five schollars[sic] and eleven hundred and eighty four volumes in libraries.

Several hopeful conversions have taken place among the scholars[sic] and a good degree of improvement had been made in all the schools.

On motion the report was accepted.

The Society proceeded to elect its officers for the coming year.

Joseph S. Fenton was unanimously chosen President.

districts in this Town.

By Mr. J. Foster Resolved that this Society view it highly important that all both old

and young be connected with the Sabbath School in the study of

the word of God.

By Mr. C. Foster Resolved that this society deem it highly important that Bible

Classes be formed in all the School in this Union.

5th
